

Terms and Conditions – 2021 MS Brissie to the Bay ‘Final Week’ Fundraising Incentive Promotion

1. Entry into the 2021 MS Brissie to the Bay ‘Final Week’ Fundraising Incentive (“Promotion”) is deemed to be an acceptance of these Conditions of Entry. Information on how to enter the Promotion and prizes associated with the Promotion form part of these Conditions of Entry.
2. Entries for the Promotion commence on 12:00hrs AEST Monday 7 June 2021 and close at 23:59hrs AEST Sunday 13 May 2021 (“Promotion Period”).
3. Entry is open to MS Brissie to the Bay participants (“Entrants”).
5. The Promoter reserves the right in their sole discretion to disqualify any individual who the Promoter have reason to believe breached any of these conditions, or engaged in any unlawful or otherwise improper misconduct calculated to jeopardise the fair and proper conduct of the competition. The Promoter’s legal rights to recover damages or other compensation from such an offender are reserved.
6. To enter, Entrants can receive a donation of any dollar amount during the promotion period and apply funds raised to their individual fundraising page for the MS Brissie to the Bay.
7. Each valid entry received during the Promotion Period will be placed in the Major Prize Draw. There is no limit to the number of entries per participant. Each additional dollar donation raised qualifies as an entry.
8. There is a total of one prize winner (“Prize Winner”).
9. The total prize pool is valued at \$4,850 (Intrepid’s 6 day ‘Cycle South Australia’s Wine Regions’ package for two adults, valued at \$4,350 + airfares in the form of a cash credit card at the amount of \$500).
10. The Prize Winner will receive the Intrepid voucher plus the cash credit card to cover airfares.
11. The Prize draw will take place at 10:00 AEST on Monday, 14 June at MS Queensland, 2B 19 Lang Parade, Milton, QLD 4064.
12. The Prize Winners will be advised within five (5) business days of the draw and their name may be published on the MS Brissie to the Bay Facebook page, and email communication.
13. The Prize Winners will be contacted by email or phone with details on how to claim their prize.
14. Entries must be received by the Promoters within the Promotion Period. Entries are deemed to be received upon the verified total of the participants fundraising page increasing by any donation amount during the promotion period.
15. Prize conditions:
 - 15.1. The value of the prize pool is accurate at the date of commencement of the Promotion Period. The Promoter accepts no responsibility for any variation in the value of the Prize after that date.
 - 15.2. This prize is not redeemable for cash.
 - 15.3. The Promoters reserve the right to change any terms contained in these Terms and Conditions of Use at any time without notice
 - 15.4. The Promoter’s decision is final, and no correspondence will be entered into, including in the event of a dispute.

15.5. If for any reason the prize is not claimed, the prize will be forfeited.

15.6. If a Prize Winner is under the age of 18 years (where entry by persons under 18 is permitted), the Promoter will award the prize to the Major Prize Winner's parent or guardian.

16. Entry to Promotion:

16.1. The Promoter reserves the right to validate and check the authenticity of entries and to disqualify any entrant for tampering with the entry process.

16.2. The Promoter and its associated agencies or companies accept no responsibility for lost, late, stolen, damaged or misdirected entries.

16.3. The Promoter has no control over internet or mobile telecommunications, network lines, bugs, viruses or server problems, and accepts no responsibility for any problems associated with them, for whatever reason.

16.4. Any entry that is lodged by automatic, repetitive, robotic, programmed or similar methods will be deemed void as determined in the absolute discretion of the Promoter.

16.5. All entries become the property of the Promoter.

17.1. If any act or omission, event or circumstance occurs which is beyond the reasonable control of the Promoter and which prevents the Promoter from complying with these Conditions of Entry, the Promoter will not be liable for any failure to perform or any delay in performing its obligations.

17.2. The Promoter reserves the right, subject to any applicable law, to cancel, terminate, modify or suspend the Promotion.

17.3. The Promoter will not be liable for any loss or damage whatsoever which is suffered, including but not limited to indirect or consequential loss, or for any personal injury suffered or sustained as a result of receiving, taking or using any Prize except for any liability which cannot be excluded by law.

17.4. The Promoter accepts no responsibility for any tax liability incurred as a result of participating in this Promotion. Any tax liability arising as a result of accepting any Prize is the responsibility of the Winner.
